

**NOTICE OF MEETING

Notice is hereby given pursuant to V.T.C.A., Government Code Section 551, that the Board of Directors of Harris County Water Control and Improvement District No. 92 will meet in regular session, open to the public, at 2:00 p.m. on Monday, November 25, 2024 at 1911 Bellchase, Spring, Texas, a meeting place inside the District, at which meeting the following items will be considered:

1. Hear from Public.

The District has adopted a policy regarding public comment. A copy of this policy will be available at the meeting. All those wishing to address the Board during the public comment period shall indicate a desire to address the Board on the applicable sign-in sheets. Public comments are limited to three (3) minutes per person for a total of thirty (30) minutes.

- 2. Constable's report and consider taking any action recommended.**
- 3. Receive report from Best Trash garbage collection and consider taking any action recommended.**
- 4. Receive Bookkeeper's report, authorize payment of bills and consider taking any action requested by the Bookkeeper, including:**
 - a.) Discuss budget and consider taking any action recommended.
- 5. Approve minutes of prior meetings.**
- 6. Receive Operator's Report and consider taking any action requested by the Operator.**
- 7. Discuss Rate Order and amend if necessary.**
- 8. Receive Recreation Advisory Committee report, including: discuss park budget and project priorities, and consider taking necessary action related thereto.**
- 9. Receive Engineer's report and consider taking any action requested by the Engineer including:**
 - a.) Approval or report, pay estimates, and change orders for construction projects in progress in the District; and
 - b.) Discuss correspondence from TCEQ and consider authorizing any action necessary for evaluation and repairs to wastewater collection system.
- 10. Receive reports from officers and consider taking any action requested.**
- 11. Receive General Manager's report and consider taking any action requested by General Manager.**
- 12. Convene in Executive Session to Receive Legal Advice, pursuant to Sections 551.071, Texas Government Code.**
- 13. Reconvene in Open Session, and consider taking action, including authorizing consultants to proceed as directed.**

Pursuant to V.T.C.A. Government Code, Chapter 551, as amended, the Board of Directors may convene in closed session to receive advice from legal counsel and discuss matters relating to pending or contemplated litigation, personnel matters, real estate transactions, gifts and donations, security devices and/or economic development negotiations.


